Each award will provide \$500 to the selected student to attend the 2009 IFT meeting in Anaheim, CA.

In addition, the Food Laws and Regulations Division will be providing ten tickets to attend the Food Laws and Regulations Division luncheon to be held during the 2009 IFT Annual Meeting.

All students with an interest in the field of food laws and regulations are encouraged to apply. Each application will be evaluated on merit and interest in food laws and regulations as well as the degree of involvement in a food science organization.

Criteria: Applicants must be:

1. Full time registered students (graduate or undergraduate) at a College or University;
2. A member of the IFT Student Association.

Procedure: The applicant must:

1. Complete the application form with accompanying supporting documents and ensure that it is received by **Friday, April 27th, 2009**.
2. Complete the required personal statement (1) and essay (2) for the travel award or the personal statement for luncheon tickets (please see below for additional details).
3. Provide 1 letter of recommendation (travel award only).
4. Winners will be notified by **May 6th 2009**, so they will have sufficient time to make their plans to participate in the meeting and luncheon.
